**Martin J. Oberman**

Chairman

Martin J. Oberman was designated Chairman of the Surface Transportation Board by President Joseph R. Biden, Jr. on January 21, 2021. Marty was sworn in as a member of the Board on January 22, 2019. He is serving in his first, five-year term following his confirmation by the United States Senate on January 2, 2019. His current term expires December 31, 2023.

Marty has had an extensive career in both the public and private sectors. His first public position was serving as the first General Counsel to the Illinois Racing Board from 1973 to 1974, where he worked closely with the Board's chairman to bring long needed reforms to the Illinois horse racing industry.

From 1975-1987, Marty served on the Chicago City Council as Alderman of the City's 43rd Ward where he earned a reputation as a reform leader, committed to promoting transparency in key governing processes while also working to reduce government corruption and profligate spending.

Following his departure from the Council, the Mayor of Chicago appointed Marty as Chairman of a special commission to fix Chicago's eroding shoreline, which required collaboration with an extensive set of stakeholders, and resulted in the publication of formal recommendations, many of which have since been implemented.

In 2013, Marty was appointed to the board of Metra, the Chicago region's commuter railroad, the second largest in the U.S. In 2014, he was unanimously elected Metra chairman and served until the end of 2016. While at Metra, he gained approval for the agency's first long term fare program aimed at tackling the agency's multi-billion dollar state-of-good-repair backlog, and led the Board's effort to institute transparency and professional management in an effort to overcome an historic culture of politics and patronage abuses at the railroad.

Most recently, he served on the board of the Chicago Metropolitan Agency for Planning (CMAP) until November 2018.

Since 1975, Marty also maintained a successful practice in Chicago as both a trial and appellate lawyer.

His unique combination of litigation experience, elected public service, and exposure to the significant complexities of railroad infrastructure finance and operations will inform his work as a Member of the Surface Transportation Board.

Marty graduated from Yale University and the University of Wisconsin Law School, cum laude, and served as a Note Editor of the Wisconsin Law Review. He has been married to his wife, Bonnie, since 1971, and has two children, and three grandchildren. Marty is a native of Springfield, Illinois.

**Patrick J. Ottensmeyer**

President and Chief Executive Officer

Mr. Ottensmeyer is president and chief executive officer of Kansas City Southern (KCS) (NYSE: KSU). He has served in this role since July 1, 2016. Mr. Ottensmeyer is also a member of KCS' board of directors. Headquartered in Kansas City, Missouri, KCS is a transportation holding company that has railroad investments in the U.S., Mexico and Panama. KCS' North American rail holdings and strategic alliances with other North American rail partners are primary components of a unique railway system, linking the commercial and industrial centers of the U.S., Mexico and Canada.

Prior to also becoming chief executive officer, Mr. Ottensmeyer served as president since 2015. From 2008 to 2015, he was executive vice president sales and marketing, and from 2006 to 2008, he was executive vice president and chief financial officer.

Prior to his employment at KCS, he served from 2000 to 2006 as executive vice president and chief financial officer of Intranasal Therapeutics, Inc., a specialty pharmaceutical company. From 1993 to 1999, he was vice president finance and treasurer for Santa Fe Pacific Corp and Burlington Northern Santa Fe Corp. Earlier in his career, Mr. Ottensmeyer held executive positions at Security Pacific National Bank and Bank of America, including the position of senior vice president and head of the corporate banking group in New York.

Mr. Ottensmeyer holds a bachelor of science in finance from Indiana University. He is U.S. chairman of the U.S. Chamber of Commerce's U.S.-Mexico Economic Council and recently served as its U.S. chairman of the strategic trade initiatives working group of the U.S.-Mexico CEO Dialogue. He is a member of the advisory board of the Woodrow Wilson Center's Mexico Institute. In 2019, Progressive Railroading magazine recognized Mr. Ottensmeyer with its Railroad Innovator Award and Railway Age magazine recognized him with its Railroader of the Year Award. Mr. Ottensmeyer serves on the boards of the Association of American Railroads, Truman Library Institute, The Civic Council of Greater Kansas City and The Kansas City Metropolitan Crime Commission.
